

## PRIVACY POLICY - SAN BENEDETTO SRL

Dear Guest,

Pursuant to the current legislation on the protection of personal data (EU Regulation n.679 of 2016), we wish to inform you that the processing of your personal data is carried out with correctness and transparency, for lawful purposes and protecting your privacy and your rights .

The treatments are also carried out with the aid of computerized means for the following purposes:

- 1.) To acquire and confirm your booking of accommodation and ancillary services, and to provide you with the requested services. The data in this case include general information and contact details, disc code and / or VAT number, credit and debit card details provided as a guarantee, deposit and / or balance, list of services and products requested and purchases, date of arrival and departure, etc. Since these are necessary treatments for the definition of the contractual agreement and for its subsequent implementation, your consent is not required, except in the case in which particular, so-called sensitive data are provided. In case of refusal to provide personal data, we will not be able to confirm the reservation or provide you with the requested services. The processing will cease upon your departure but some of your personal data may or must continue to be processed for the purposes and in the manner indicated in the following points;
- 2.) To fulfill the obligation set forth in the "Consolidated Law on Public Safety" (Art. 109 RD 18.61931 n.773) which requires us to communicate to the Police Headquarters, for purposes of public safety, the details of the clients accommodated in accordance with procedures established by the Ministry of the Interior (Decree of 7 January 2013). The provision of data is mandatory and does not require your consent, and in case of refusal to provide them, we will not be able to host you in our structure. The data acquired for this purpose are not stored by us, unless you give us the consent to the storage as provided for in point 5;
- 3.) To fulfill the obligation set by the Municipality of Peschiera del Garda for the payment of the Tourist Tax, which requires us to communicate, through the platform adopted by the municipality itself (PayTourist, owned by Kitesun Srl), the details of the customers who stay at our facility. In this case, the data controller, pursuant to Art. 4 paragraph 7 of the GDPR, is the Municipality of Peschiera del Garda, with headquarters in P.le Betteloni, 3 - 37019 - Peschiera del Garda - VR. - 4.) To fulfill current administrative, accounting and tax obligations. For these purposes, the processing is carried out without the need to acquire your consent. The data not processed by us and by our representatives, and is communicated externally only in compliance with legal obligations. In case of refusal to provide the data necessary for the aforementioned obligations, we will not be able to provide you with the requested services. The data acquired for these purposes are stored by us for the time required by the respective regulations (10 years, and even longer in cases of tax assessments).
- 5.) To speed up the registration procedures in case of subsequent stays at our facility. For this purpose, after obtaining your consent, which can be revoked at any time by communicating to

- info@villaggiosanbenedetto.it, your data will be kept for a maximum period of 12 months, and will be used when you are again our Guest for the purposes referred to in points previous;
- 6.) To carry out the function of receiving messages and telephone calls addressed to you during your stay. Your consent is required for this purpose. You can withdraw your consent at any time by communicating to info@villaggiosanbenedetto.it. The treatment will in any case cease upon your departure;
  - 7.) To send promotional messages and updates on rates and offers. For this purpose, after obtaining your consent, your data will be kept for a maximum period of 12 months and will not be disclosed to third parties. You can withdraw your consent at any time by communicating to marketing@villaggiosanbenedetto.it;
  - 8.) Photo. We inform you that during the season and the animation activity, photos and videos will be taken that could affect the entire extension area of the San Benedetto. While carrying out this type of activity, you will find appropriate signs indicating the area of interest. We therefore invite you to participate in the creation of this important puzzle of wonderful memories, because we are who we are also thanks to you. But, if you do not wish to be portrayed (you and / or your minor children) in our context, you can safely move away from the lens.
  - 9.) For the protection of persons, property and company assets through an automated system for opening / closing the access bars to the structure and managed by a software that records the user's license plate to allow access and exit during his stay. Your consent is not required for this treatment, as you pursue our legitimate interest in protecting people and in good respect of possible illegitimate access to the structure itself. The registration is canceled at the end of your stay. Registration is not communicated to third parties.

We wish to inform you that San Benedetto is not responsible for values or objects left in the housing units, nor for damage or theft of objects contained in vehicles parked in the structure or in the surrounding areas.

We also wish to inform you that the European Regulation recognizes certain rights, including the right of cancellation or limitation or opposition to processing (Articles 15 to 22 of EU Regulation no. 679 of 2016). You can also lodge a complaint with the Supervisory Authority, according to the procedures provided for by current legislation.
