

## REGULATION

### **Art. 1 – Safety, prevention and contrast Covid-19 virus**

Accessing the spaces of the San Benedetto Vecchio Mulino camping village, our Guests, aware of the civil and criminal responsibilities deriving from the falsity of documents and false declarations, pursuant to and for the purposes of current legislation, due to the stay at the aforementioned structure, assumes also the responsibility for all the components of its Unit and declares and accepts:

- The present and future procedures established by the Directorate for the prevention and contrast of the Covid-19 virus, also due to any new provisions of the Health Authority;
- to be in possession of the National Green Pass;
- not to be positive for Covid-19, not to undergo the mandatory quarantine measure;
- of, in the event of having previously tested positive, be in possession of a Medical Certificate drawn up by the Health Authority, which certifies complete recovery;
- not had direct contact with Covid-19 positive persons in the previous 14 days;
- not have symptoms attributable, to the best of its knowledge, to Covid-19, and not have had today and within 5 days before a body temperatures above 37.5 °;
- to promptly notify Management of any symptoms attributable to Covid-19;
- to be aware that, although the San Benedetto camping village scrupulously adopts and applies all the Health Authority rules for the control of the risks, these can never be completely eliminated;
- to actively collaborate in following the instructions and provisions provided by the Management of San Benedetto camping village, with particular reference to individual and collective behavior and to the measures to be taken to contain the risk of contagion from Covid-19;
- to always have the mandatory personal protective equipment (surgical face mask or similar, disposable gloves, sanitizing liquid), for the prevention and protection against the risk of contagion from Covid-19;
- any changes or cancellations of activities or of the stay itself, in relation to the possible appearance of symptoms from Covid-19, by oneself or by one's relatives, and / or by the identification of any possible source of contagion risk, on the unquestionable judgment of the Management of San Benedetto Vecchio Mulino camping village.

### **Art.2 – Check-in**

In compliance with the health and government regulations in force, it is possible to access the Camping only by wearing an individual protection face mask (adults and children from 6 years old). On the day of arrival, all Guests are required to show their personal documents, one for each, for legal registration, view and fully accept the Regulation and safety measures put in place to combat the spread of Covid-19 as required by the competent Authorities (see point 1) when filling in the privacy policy, and to show any promotional cards (ACSI, ANWB, Camping Club, etc.) in order to apply the dedicated rate. During the check-in, each Guest will receive an identification bracelet which must be worn on the wrist for the entire duration of the stay. The Management reserves the right not to accept Guests who do not present valid documents or that is not consistent with the characteristics of the Campsite. Under-age people can enter the camping village only when by supervisor, parents, relatives of age or adults who will take full

responsibility for them towards third parties. The entry of people or things to the campsite is always subject to the consent of the Management. The assignment of the place is made by the Management who will inform the Guest of all the provisions to which they must comply during their stay. Any change of place or extension of stay will be allowed only following specific authorization from the Management. Failure to comply with these Regulations will result in immediate removal from the Campsite.

### **Art.3 – Opening times**

The entry barrier will be open from 6:00 am to 12:00 pm. Outside these hours, all annoying noises, as well as entry and exit from the Campsite by motor vehicles are strictly forbidden and therefore, in order to avoid unpleasant discussions, it is highly recommended to plan arrivals as well as entry and exit from the Campsite. For quiet living, we kindly ask our guests to reduce movement of any motor vehicles; in any case, the maximum speed allowed inside the campsite is 5 km / h for any motor vehicle.

### **Art. 4 – Desk**

The reception is open from 8:00 am to 10:00 pm, while the cash desk for the payments is open from 8:00 am to 12:00 am and from 5:00 pm to 8:00 pm. Outside this time frame, no payments will be allowed, there will be no possibility to take any documents back, etc. No exception made. The offices may reduce opening times, depending on the season. The Night Watchmen are present at the Reception from 10:00 pm to 8:00 am.

### **Art.5 – Pitches**

The reserved pitch will be available from 2:00 pm on the day of arrival and must be vacated by 12:00 am on the day of departure. The assigned pitch is bordered and therefore all equipment, included the car, must remain within such borders. In compliance with the regional provisions aimed at containing the infection, the access door to the accommodation located on the pitch must necessarily be at a distance of 3 m from the neighboring pitches. Only one equipment (1 car + 1 caravan; 1 car or scooter + tent; camper) can be installed on the pitch, therefore anything else must be considered extra, and so to be paid according to the current pricelist. The installation of the equipment must follow the registration at the desk. It is forbidden changing the place assigned by the Management. Energy supply on each pitch is minimum 6 A. The car on the pitch must be parked at least 1 m far from the caravan / tent. It is strictly forbidden to wash caravans and cars on the pitch (please, use the camper-service area). It is not mandatory to wear a face mask inside your pitch, but it becomes so when you leave your perimeter to move to the camping village.

### **Art.6 – Mobilhome**

The Mobilhome booked is available from 5:00 pm on the day of arrival and must be vacated by 9:00 am on the day of departure (except for few type of Mobilhome, with check-out at 12 am). Upon delivery of the keys, a deposit is required and will be returned upon departure, after checking. Guests are invited to take care of the equipment inside the Mobilhomes and Mobilhomes themselves, and to take care of the outdoor equipment, especially in case of particular weather conditions. Parking near the structures is not allowed, with the exception of some types of Mobilhome. Only baggage unloading / loading operations are allowed, which must take place without hindering normal circulation. There are ample parking spaces, unnumbered, for parking cars / motorcycles during the stay. At check-out, the check of

the housing unit is carried out only when the keys are returned, remembering that the departure must take place during office hours. Otherwise, the check will be carried out at a later time and the return of the deposit paid at check-in time, will be made by bank transfer with expense to be paid by the beneficiary. It is not mandatory to wear a face mask inside your mobile home and its patio, but it becomes so when you move away to go to the camping village.

### **Art.7 – Use of facilities**

The use of all the camping facilities will be allowed in accordance with rules and times established by the Management. Respecting the intended use of all facilities is mandatory, especially sanitary ones. In particular, restrooms will be opened progressively, according to the number of Guests and their needs. In compliance with the health provisions in force, it is mandatory to sanitize your hands with alcoholic gel (present both outside and inside the toilet groups, in special distributors installed clearly visible) before and after coming into contact with taps, mixers, door handles, hangers. For what concerns the use of personal devices such as radio, TV, etc. it is allowed but without disturbing the other guests.

### **Art. 8 – Swimming pools**

The use of the swimming pools is strictly reserved to the guests of the Campsite. It is recommended to respect the specific Regulations placed at the entrance of the pools area. The Management reserves the right to remove anyone who will not respect the regulation and who disturb other Guests. The Management declines all responsibility for accidents caused by ignoring these rules. In particular, in compliance with the health provisions currently in force, the entry into the pool, quota, is allowed compulsory wearing a swim cap, after making a soapy shower on the whole body, and respecting the safety distances, as set forth in the Regulations on site.

### **Art.9 – Children**

All children under 10-years-old who stay at the campsite must be followed by an adult who will take responsibility for them to third parties, freeing the Management and the property from any liability. The Management declines therefore all responsibility for accidents caused by ignoring these rules.

### **Art.10 - Tourist tax**

It is about € 1.10 and is paid at the time of the balance of the stay. It applies per day per person up to a maximum of 21 consecutive nights, with the exception of children of or under 12 years old and all the designated categories as stated by the Municipality of Peschiera del Garda.

### **Art.11 – Security**

The campsite is fenced. A security service is provided by personnel who will be easily recognized during day and night, however guests are invited to pay attention to their belongings, as the Management is not liable for any thefts except for things expressly delivered to the Office. The staff must ensure compliance with the rules contained in this Regulation. Guests accept to collaborate with our security anytime they might be asked to and, if requested, to provide personal information as well as details relating to the stay at the Campsite.

### **Art.12 – Pets**

Pets are allowed only after authorization and verification of the mandatory health documentation. The owner must take care of the pet's hygiene, reminding not to disturb the other Guests. Dogs must always be kept on a leash. It is forbidden to enter the swimming pool area, Elite and Top Village area. Pets are allowed only in some types of mobilhomes. It is strictly forbidden to wash pets inside toilets and in any case in any area of the campsite except at the Pet Bath, a specific area available in the Services Group located near the Reception. We would kindly remind you that it is strictly forbidden to leave pets alone in mobilhomes or pitches.

### **Art.13 – Diseases**

All contagious diseases must be immediately reported to the Management who, as needed, will act accordingly by expelling the Guests concerned.

### **Art.14 – Environment**

It is forbidden to waste or use water improperly, or leave waste outside the appropriate containers, throw the burning embers on the ground or inside the waste bins, pour oils, boiling, salty or waste liquids on the ground, damage the flora existing in the campsite, light fires. Only the use of gas BBQ is allowed; alternatively, an equipped area (Fire point) is available, fenced, where it is possible have bbq with charcoal / wood, following the rules of conduct and safety shown. It is forbidden to delimit the pitches with fences, fences, flower pots or anything else.

### **Art.15 – Recycling**

At San Benedetto we take particular care of recycling. Designated drop-off points have been set up throughout the area of the Village: we highly recommend to all of our guests to use them correctly and use the transparent bags for dry waste and biodegradable bags for wet waste. Plastic, paper and glass must be without any bag. It is strictly forbidden to use black or non-transparent bags since all the wastes must should be recognizable.

### **Art.16 – Visitors**

Visitors are allowed to enter the campsite only after the authorization of the staff, and providing identification document and the payment of the relative fee. In compliance with the governmental and regional regulations in force aimed at combating the infection, a declaration of good health is required from all those who enter the Village. We also kindly remind you that all visits must be agreed in advance with the Management which, according to the availability, may or may not give the consent. Entry is allowed only by wearing a face mask and on foot, therefore, cars should be left outside, without compromising normal traffic circulation. It is understood that those who receive Guests are responsible for their behavior.

We invite our kind Guests to view the recycling points and escape routes on the Emergency Plan displayed.

All the provisions set out in this Regulation, adopted at San Benedetto Vecchio Mulino camping village for the prevention and combat to Covid-19, may, following precise government regulations, be subject to modifications, adjustments and variations during the stay. The Guest unconditionally undertakes to respect them, accepting any new action that must be taken.
